1	Welcome and Introduction	<p>The Chair of the Community Reference Group, Rodger Eade, introduced himself and welcomed participants to the workshop. Rodger explained his role and then asked those present to introduce themselves and to briefly identify what they, and the community they represent, would like the study to achieve.</p> <p>Apologies noted on previous page.</p>
2	Study Explanation	<p>2.1 Process and Administration Bob Evans, Study Director, and William McDougall, Study Manager, explained the draft study process and administrative structure of the study team, and identified the main objectives of the study, which is to improve the amenity and transport system of the area. Some of the transport problems in the area were identified, including traffic congestion, lost time, and public transport delays. The study will include consulting with the community and those municipalities adjoining the study area.</p> <p>(Copies of the Power-point presentation were tabled)</p> <p>2.2 Assessment Framework The CRG was invited to contribute any comments and/or suggestions as to how the study process could possibly be improved. In particular, the assessment framework, which highlights a set of criteria and options to guide the study consultants, is an area where the CRG has the opportunity to contribute to the shaping of the process and assessment methods of the study.</p> <p>2.3 Links to other Projects The study team explained that the study is running parallel with the Government's Metropolitan Strategy. The key principles and objectives of the Metropolitan Strategy will aid the study. The Metropolitan Strategy will also set some network context. Links to other transport and land use studies, such as the Outer Western Area Study (to commence in the near future) were also identified as important 'watching briefs' during the study.</p>
3	Study Progress	<p>3.1 CRG – Terms of Reference (TOR) The study team explained that the Minister had approved the Terms of Reference for the CRG. The Chair then called for open discussion on the T.O.R. The CRG asked what process would be in place to ensure the community had access to current issues arising from the study and their opportunities to contribute to the study.</p> <p>Jullianne Bell asked why the Public Transport Users Association was not invited to be part of the CRG. The study team responded by saying that the present membership to the CRG was viewed as adequately representing a broad cross-section of public transport user groups. The CRG was also informed that the study team would meet with other organisations not part of the CRG membership if requested, such as the PTUA, to hear their views.</p>

		<p>3.2 Communications Strategy The study team responded by explaining that the Communications Strategy was underway and is being carried out with the help of the DOI Public Affairs Branch. It includes the goals, objectives, key messages, target audience and an action plan for each of the elements of the strategy. In conjunction with the Communications Strategy is the opportunity to communicate directly by phone, fax or e-mail with the study team and representatives on the CRG. All inputs towards the study are to be placed on a central database and information collected throughout the consultation phase of the study will be reported back to the CRG.</p> <p>3.3 Study Briefs The closing date for the briefs is 26 April 2001. The successful consultants will be invited to attend the CRG meeting scheduled after the Community Forum on 23 May 2001, and will also receive previous CRG Meeting minutes to assist them with their studies. Comments on the study briefs were welcomed.</p> <p>3.4 Community Information Bulletin Robert Abboud asked what area would the Information Bulletins (community updates) cover in the general community. The study team responded by saying that a letter drop would be done to all properties in the immediate core study area. Kaye Oddie and Peter Navaretti requested that notice is given to both owner and occupier, of which was agreed.</p>
4	CRG Media Protocol	<p>Cr Robyn Williams asked whether the CRG could directly talk to the media about the study. The Chair responded by saying that individuals on the CRG, representing their own views, can talk to the media but cannot represent the collective views of the CRG.</p>
