CORRIDOR STUDY

ON MELBOURNE'S INNER NORTHERN SUBURBS?

The Bracks Government, as part of the Northern Central City Corridor Study, is investigating transport and land-use issues in Melbourne's inner northern suburbs.

The study will look at issues in relation to traffic congestion, delays, pollution and other problems experienced by residents and users of the inner northern suburbs of:

- Abbotsford
- Carlton and Carlton North
- Clifton Hill
- Collingwood
- Fitzroy and Fitzroy North
- North Melbourne
- Parkville
- Princes Hill.

The study will develop strategies covering all forms of transport, including public transport, cycling, walking and road traffic to address these concerns. The study will also examine opportunities for land use, urban design and heritage conservation in the area and will be developed in collaboration with other major government programs such as the Metropolitan Strategy.

The Department of Infrastructure is coordinating the study in liaison with Melbourne City Council and Yarra City Council. The study will result in the release of a draft Northern Central City Corridor Strategy in March 2002 before the study is finalised in May 2002.

As a starting point, we would like the community's views on transport, living and working conditions in the inner north area. We have provided a variety of opportunities for the public to contribute ideas and opinions.



I greatly encourage the community to make use of these opportunities to contribute to this important program that, in turn, will contribute to the sustainability and liveability of Melbourne's inner north.

STUDY PROCESS

The Northern Central City Corridor Study is about providing the community with the chance to help build a transport and land-use strategy for the inner north. To this end, the study will:

- consult with the community over transport and land-use issues and opportunities in the inner northern suburbs
- review existing and possible future transport patterns and their impact on local communities
- identify road and public transport needs and how to manage their impacts
- identify any opportunities for urban design and land-use planning initiatives
- develop and present alternative transport strategies for public comment.


The process will include several stages and aims to get broad community support for:

- objectives for transport and amenity in the inner northern suburbs
- measures to form part of an integrated strategy
- criteria against which options will be assessed
- selection of a preferred strategy and its various components.

A previous study, initiated by the former Kennett Government, looked at the possibility of a road tunnel between the Eastern Freeway and City Link, and between the Eastern Freeway and the CBD. Engineering and operational issues were identified and alternative solutions were suggested in that study. The Bracks Government has reviewed the previous study and has decided that a more integrated approach is needed for the inner north area to provide a comprehensive package of measures to improve transport conditions and the amenity of the area.

The Northern Central City Corridor Study is being overseen by the Minister for Transport in conjunction with councillor representatives from the Cities of Melbourne and Yarra. The ministerial/councillor group will meet regularly to be briefed on the study's progress and to review the results of consultation and research conducted as part of the study.

STUDY TIMETABLE

The study is established and a Community Reference Group is appointed to work alongside the study team and the ministerial/councillor group. A technical steering committee with representation from the Cities of Melbourne and Yarra, the Department of Infrastructure, the Office of the Director of Public Transport and VicRoads is also set up to oversee the study process.

A community forum will be held to canvass the public's views and ideas on how we can better manage the transport and land-use needs of the inner north area.

A report on the existing transport and land-use conditions in the area will be released to provide background material as part of the consultation

process.

October 2001 A report detailing all the transport and land-use options for the inner north area, based on community feedback, will be released for public

discussion.

A draft strategy outlining a short list of options for the area will be prepared and released for public comment prior to the finalisation of the

strategy in May 2002.
